INTRODUCTION

Eosinophilic Esophagitis (EoE) is a chronic condition manifested by symptoms of abdominal pain, nausea, regurgitation and/or vomiting or dysphagia that occurs in the setting of an isolated eosinophilic inflammation of the esophagus. EoE continues to be a clinico-pathologic disease, in that both clinical symptoms and a histologic diagnosis must be made in order to make a correct diagnosis. It is not known whether treatment will impact longterm outcomes of the disease, and the exact end points (reversal of symptoms and/or the need to achieve endoscopic or histologic normal mucosa) are not certain. The lack of evidence continues to make decisions regarding choice and duration of treatment difficult. There is a great need to continue to educate and present current state of the art findings related to EoE to specialists, primary care physicians, nurses, dietitians and trainees.
